Ma is the Resident Assistant on duty for Myers Hall at the time of the report. Ma had taken a picture of the white board prior to notifying the police. Ma took us up to room [REDACTED] of Myers Hall where a picture of a males penis with flames around it that was drawn on a dry erase board. Ma's picture had the words "FIRE CROTCH" with the picture next to it. When I arrived at the room of 359 the words had been erased from the white board, but the picture remained on the board. Ma stated that she was walking down the hall when she saw the picture on the white board. Ma stated that she saw the drawing at 0110 hours on 082210. I met with the residents of the room of [REDACTED] of Myers Hall. The residents (Cho, Christopher [REDACTED]) (Day, Michael [REDACTED]) stated that it happened between 0000 hours and 0200 hours on 082210. The residents did not want to prosecute and erased the drawing from the board. No permanent damage was done to the board. Photographs were taken. Ma filled out a witness statement. There was no type of surveillance in the hallway. Ma was given a case reference card.

On 092510 at 1331 hours I was dispatched to Lipscomb Hall in reference to an act of intolerance. I met with the reporting party who is a Resident Assistant on the second floor of Lipscomb Hall. She advised that an unknown individual had written "Southern trees bear strange fruit" on a dry erase board located on a door that led to a maintenance closet. This door is located on the second floor on the north wing. The reporting party explained to me that this phrase referenced lynching. She advised that this was found by the third floor Resident Assistant. I contacted the third floor Resident Assistant via telephone. She advised that this act occurred between 091910 at 1830 hours and 092410 at 1830 hours. Photos were taken of the dry erase board. I then wet my finger and erased the phrase from the board. The reporting party was given a CRN card.
