Electronic Mail

Whenever you send electronic mail, your name and user ID are included in each mail message. You are responsible for all electronic mail messages originating from your user ID. Therefore:

1. Forgery (or attempted forgery) of electronic mail messages is prohibited.
2. Attempts to read, delete, copy, or modify the electronic mail of other users are prohibited.
3. Attempts at sending harassing, obscene and/or other threatening e-mail to another user are prohibited.
4. Attempts at sending unsolicited junk mail; "for-profit" messages or chain letters, is prohibited.
5. Displaying sexually explicit, graphically disturbing, or sexually harassing images or text in a public computer facility or location that can potentially be in view of other individuals is prohibited.

Free Speech

The rights of free speech and peaceful assembly, as enumerated in the Constitution of the United States, shall be upheld and protected by Colorado Mesa University. The University acknowledges the rights of students and others to assemble on the University campus for peaceful rallies, demonstrations, and gatherings. In support of this effort, the University has established reasonable accommodations and regulations regarding the time, place, and manner in which persons may exercise their rights to free speech to assure the orderly operation and safety of the campus community.

In an effort to support the rights of students and others, a Free Speech Zone has been designated within the perimeter of the University. The concrete patio adjacent to the west door of the University Center has been designated the Free Speech Zone. The location is a central pedestrian thoroughfare for daily campus life and easy access to classroom, residential, and activity centers on campus.

While the area has been established as the gathering point for students and others to exercise their right to free speech, the rights and privileges of all persons shall be respected and there will be no tolerance for activities that endanger the health or safety of the campus community, visitors, or guests. In regards to the area west of the University Center, this area is associated with the entrance/exit to the University Center itself. If this area is being used, a clear path into and out of the University Center must be made available and not disrupt the flow of traffic for those using the facility. Additionally, such gatherings must not unreasonably disrupt the normal conduct of University operations or endanger University property or persons.

In the event safety becomes an issue to the University, its students, staff, and faculty, or the individual or organization(s) involved in free speech activities, this policy does not limit

or constrain the University or law enforcement authorities to maintain and protect public safety, as established in law.

Immunization Policy for Measles, Mumps, and Rubella

Colorado State Immunization Law states that after July 1, 1992 all university students born since January 1, 1957 must have two (2) measles, two (2) mumps, and two (2) rubella doses. If the student received a second measles dose prior to July 1, 1992 the second mumps and rubella are not required. Written evidence of titers (blood test) showing immunity to measles, mumps, and rubella is acceptable. If the student completes an exemption form and an outbreak occurs, the student will be subject to exclusion from the school. Students must prove compliance before the add/drop deadline of their first semester, or they will not be allowed to register for further classes.

Each new, incoming freshman student residing in University housing is required by Colorado Statute to complete a form upon check-in indicating whether or not the Student as received a meningococcal vaccination.

The vaccination is voluntary; the decision to vaccinate is one the student, parent(s), or guardian(s) should make in consultation with their family health care provider.

1. Meningococcal disease is a serious disease.
2. Meningococcal disease is a contagious, but a largely preventable, infection of the spinal cord fluid and the fluid that surrounds the brain.
3. Scientific evidence suggests that university students living in dormitory facilities are at a modestly increased risk of contracting meningococcal disease.
4. Immunization against meningococcal disease decreases the risk of contracting the disease.

Vaccinations may be available through your family health care provider, Colorado Mesa University Student Health Center, or your county health department. Please check with your health insurance to see if the vaccination is covered by your policy.

Parking

All parking on the Colorado Mesa University campus is regulated from 6:00 a.m. to 6:00 p.m. weekdays, during the school year. During breaks only pay to park and reserved lots are enforced. Parking is restricted to either pay-to-park or permit required lots. Reserved parking is available only to reserved space permit holders.

All parking lots are marked with signs explaining their requirements. The City of Grand Junction regulates parking on City streets with the exception of Houston, Cannell and Elm Avenues.

Parking permits are available on an annual basis and all permits expire on August 1st of each year. Permits may be ordered online and picked up at the University Center Information Desk. Pay-to-park lots require a fee of \$1.00 per hour. Colorado Mesa University Parking Services has the responsibility of regulating parking on campus.
